Submit an offer

Our company does not make “offers” to customers. We do not offer an artist to a buyer at a fixed rate. We can assist you in preparing an offer that will be presented to an artist. In other words, you, the buyer, will be the one who submits an offer.

For example, a basic offer would read, “I am prepared to offer Mr. the Artist €10,000 plus travel, accommodation and any other expenses necessary for you to host my event”.

Offers are not submitted unless they are serious and you are prepared to honour the terms you present in your offer.

Engagement conditions

When submitting an offer, you declare that you are ready to take the next step, if your offer is accepted. In this procedure, a financial commitment of good faith of 10 to 25% is requested as a validation/guarantee of the offer. It confirms to us that you are serious to continue according to the terms of your offer and that you are ready to proceed with a full contract, in case of acceptance of your offer by the artist.

An offer not guaranteed by an undertaking is unlikely to be seriously considered. You will have to send your commitment by bank transfer within 24-72 hours of submitting your offer. Otherwise, we will not be able to process your file. You cannot say “I will send the undertaking after the artist has accepted my offer and I will receive a contract”. Such a payment is called a “down payment” and not a “commitment”. Do not confuse these two terms. A “commitment” is transferred BEFORE an artist considers or accepts an offer. A “down payment” on contract is transferred AFTER the artist’s acceptance.

Summary

A commitment (Offer): due immediately after an offer has been submitted, and before the offer is forwarded to the artist for consideration. Without a commitment, no action can be taken on an offer. The commitment is proof of the buyer’s good faith.

Down payment (Contract): due when the artist has provisionally accepted the offer and the contracts are published. If the artist does not accept your offer, 100% of the commitment is promptly returned to you – or, at your request, the funds can be kept as your commitment for an offer made to another artist.
